# + DOE Compliance RFI

- DOE's Building Energy Codes Program (BECP) released a Request for Information (RFI) on August 6, 2013: "DOE Activities and Methodology for Assessing Compliance with Building Energy Codes"
  - New submission deadline: September 30, 2013
- This DOES NOT relate to the Recovery Act 90% code compliance provision (Section 410)
- The intent with this RFI appears to be to provide DOE feedback on a variety of compliance-related issues, including:
  - Methodology developed for DOE's energy code compliance evaluation pilot studies in nine states
  - Fundamental assumptions and approaches to measuring building energy code compliance

# + DOE Compliance RFI

## RFI Categories:

- Defining and Achieving Compliance
  - Definition of compliance and barriers
- Costs and Benefits
  - State/national/consumer benefits of compliance, and cost of ensuring compliance
- Compliance Targets
  - How to measure compliance and track progress

#### Evaluating Compliance

- Who should evaluate compliance (State Energy Offices, local jurisdictions, contractors hired by state, etc.)?
- Where should funding come from?

#### DOE Compliance Evaluation Resources and Actions:

- What resources should DOE provide?
- How could incentive funding be used to help states increase code adoption and compliance efforts?

# Other Building Energy Code Compliance Initiatives

- Increasing energy code compliance through use of rate-payer funded energy efficiency programs continues to be a topic of interest
  - Pacific Northwest National Laboratory (PNNL) is developing a "Utility Savings Estimator Tool" to help estimate the electric and gas energy savings that can be achieved through increased code compliance level; Version 1.0 anticipated in October
- NASEO report: "Leveraging State Energy Office-Utility Partnerships to Advance Building Energy Codes"
  - Examined existing state-utility partnerships to support code adoption and compliance and provided recommendations
- Recent Cadmus/NEEP/IMT/IEE report: "<u>Attributing Building Energy Code</u> <u>Savings to Energy Efficiency Programs</u>"
  - Explores options for developing code programs that can be recognized like conventional energy efficiency programs that produce savings
- DOE April 2013 Code Compliance Technical Meeting
  - Included presentations from state representatives from Massachusetts, Minnesota, and Washington on approaches to code compliance

## + Upcoming ICC Hearings

- International Code Council is holding Public Comment Hearings October 2 -10, 2013 in Atlantic City, New Jersey
  - Final votes for the 2015 International Energy Conservation Code (IECC) will take place Oct. 5 – 10
  - NASEO has travel scholarship funding available for State Energy Offices that plan to attend

    - ICC registration deadline was August 30, 2013

## + Upcoming ICC Hearings

- Concern among some energy efficiency organizations that the 2015 code will "backslide" compared to 2012, especially on the residential code.
- Residential code proposals of note:
  - RE-166: would restore the Equipment Trade-Off provision that was previously voted out of the IECC
  - RE 188-13: voluntary performance compliance path for 2015 IECC; meet mandatory requirements plus a target "Energy Rating Index" score (HERS or other) based on climate
  - RE 186: "Builder Flex Beyond the 2012"; approach to achieve 5% energy savings above the 2012 IECC based on multiple options that a builder can select
